YOUR PRIVACY

Your privacy is important to us. We never have and never will collect your information. This policy has been created to better protect your privacy. This page explains our online information practices and our legal basis for doing so.

Cambodian Charity Organization (CCO) based in Phnom Penh, Cambodia and all activity / program we will publish in CCO website or CCO social media.

By using our CCO website or social media, you're acknowledging you have agreed to our Terms of Use and that you have read and understood this Privacy Policy.

CHANGES TO THIS POLICY

We may update this Policy from time to time. If we do, we'll update about any material changes on the website and if you keep using our website after a change, that means you accept this Policy.

PERSONAL INFORMATION

You can access our website or CCO social media without disclosing any personal data. We do not automatically log personal data nor do we link information automatically logged by other means with personal data about specific individuals.

When you make a donation by online or direct bank-in to CCO account, we need donor information (name, address, amount, phone or email address, date of transaction) that allows us to process and record your donation. Maximum donation not more than \$50,000 per transaction and donation are not allowed to refund.

CCO does not use cookies to store information about specific individuals. You have the ability to accept or decline cookies by changing settings on your computer. You can see and use our sites even if you disable the cookie function on your browser.

However, if you disable cookies, some advanced and customized features of our site may not be available to you. We do analyze our website logs and user statistics to improve the value of our site. Our logs and user statistics are not personally identifiable and we make no attempt to link these logs and statistics with individuals who view our sites. These logs are reviewed for aggregate trends, not for the behaviors of individual users. Only authorized staff has access to our website logs and user statistics.

OUR WEB SITE'S SERVICES AND LINKS

The only information on our website is CCO information. It is for contact between visitors and CCO, it does not enable our visitors to communicate with other visitors or to post information for others to access. Our site includes links to other sites. If you choose to visit another site, we cannot assume responsibility for its content or information handling practices. **We encourage you to review each site's privacy policy.**

DATA COLLECTION & PURPOSE SPECIFICATION

We do not look for or collect information about our visitors from other sources such as public records or private organizations. We do not compile, buy, sell, rent, share or trade consumer mailing lists. The only personal data we collect is that which you freely give us when you use some of the functions on CCO websites, particularly as relates to a donation or sponsorship.

CCO does not knowingly collect personal data from anyone under the age of 18. We will never share, sell, trade or provide your personal information to non CCO organizations unless required to do so by law. When we ask you for personal information we will give you a secure transmission method to send us :

- Your primary personal data, such as your name and contact details
- Other personal and profiling data, such as your family details, how you heard about us, your personal comments, etc.
- Personal identifiers, such as your credit card details

CCO has implemented its own security policies, rules and technical measures to protect the personal data that we have under our control from:

- Unauthorized access
- Improper use or disclosure
- Unauthorized modification
- Unlawful destruction or accidental loss

Any CCO employees or data processors that have access to and/or are associated with the processing of personal data are contractually obliged to respect the confidentiality of our visitors' personal data.

We also ensure that your personal data will not be disclosed to national or local authorities, agencies or institutions except where required by law or other legally enforceable regulation. If, for any reason, our privacy policy changes, we will post and explain our intention on our website and give you a clear opportunity to opt out of this new policy. We may also contact you directly by email to inform you of our intention and seek your agreement directly. If you don't agree to this new use, we will not use your information. You can ask us if we hold any personal information about you, what it is and how we use it by:

If we hold any relevant information about you, we will provide you with a copy of that information. We will not charge you for providing you with the information. We will request proof of identity before releasing any information.
